Community Shares honors all donor designations. In fact, donors are encouraged to designate to agencies they specifically want to support.


We honor write-in designations to any 501(c)3 nonprofit within the United States.

# Where the Money Goes



- Community Shares hosts campaigns to generate essential funds for LOCAL nonprofits.
- Funds that are donated through Community Shares are delivered to the donor's choice of nonprofit(s).
- Donations through Community Shares are provided to the designated nonprofits <u>completely unrestricted</u>!



# Community Impact

Advocating Opportunity assisted 214 clients and handled 535 legal matters.

**Arts Commission of Greater Toledo** invested in almost 300 artists and provided funding for ten large scale projects.

**Beach House (dba Leading Families Home)** emergency shelter and housing programs served 502 individuals (including 290 children and 9 veterans) in 170 households in 2020.

**Bethany House** provided 14,000 nights of safe shelter to survivors of domestic violence.

**Cancer Connection of Northwest Ohio** provided free programming to 484 new parents/families, personal assessments to 121 new patients, and made 1,452 monthly check-in phone calls. **Children's Rights Collaborative** served 68 families and 112 children, representing more than 900 hours of service to the community.

**Down Syndrome Association** served 120 individuals with Down syndrome and their families through 17 programs.

Hannah's Socks distributed 97,506 pair of new socks to 24 regular monthly partners.

**League of Women Voters of Toledo-Lucas County** maintains a Voters Guide, provides assistance to new citizens, and informs newly released felons of voting rights.

Make-A-Wish granted 824 wishes in 2019 and 485 wishes in 2020.

MLK Kitchen for the Poor feeds more than 200 people each day.

Nature's Nursery answers over 200 emergency calls per week.

**Partners for Clean Streams** volunteers removed 20,121 pounds of trash near rivers & streams.

**Scrap4Art** diverts 2,000 pounds of materials from the solid waste stream each year.

**Sylvania Area Family Services** served 11,500 individuals in 2020.

**Wood County Humane Society** rehomed 717 animals (464 cats, 234 dogs, 19 pocket pets) 2020



# Donor Impact



- Scholarships for 3 individuals with Down Syndrome to learn and grow through a camp or therapeutic activity.
- Removal of 156 pounds of garbage from an area river or stream.
- Spay/neuter surgery for a small dog or two cats.



- 1 teen's daily expenses for a week-long Bike Adventure with their mentor.
- Beds, pillows, sheets & blankets for 2 people emerging from homelessness
- Funding for a Stage 4 Support Group for terminal cancer patients and their families to talk openly about their struggles



- Florida theme park tickets for a Make-a-Wish family of 4.
- Three weeks of safe shelter and advocacy services to a victim of domestic violence.
- An attorney to help prevent a family of four from being wrongfully evicted.
